Air France Repatriation Flight Conditions

All passengers are personally responsible to arrange and be in possession of the required health and travel documentation such as passport, visas, health certifications (negative RT PCR test) and any relevant documents for entry into Vietnam. Upon reception of all the required documents by the authorities of Vietnam according to the deadlines, Air France will submit a list of passengers (with all the required documents) and will apply for the landing permit to CAAV (Civil Aviation of Vietnam). After 5 working days, CAAV will deliver the landing permit with an approved passenger list. If the CDG SGN repatriation flight is not approved or/and your submission is not approved, the ticket will be refunded (refund fees might be applicable). Passengers allow Air France to take and retain copies of their passport or other documentation. Air France reserves the right to refuse to transport a passenger and his baggage if the passenger has not complied with these requirements, or if the travel documents do not appear in order. Air France will take all necessary measures to operate the CDG SGN repatriation flight. In the event the CDG SGN repatriation flight is delayed or cancelled, Air France shall take adequate steps to support passengers but has no liability with respect thereto.

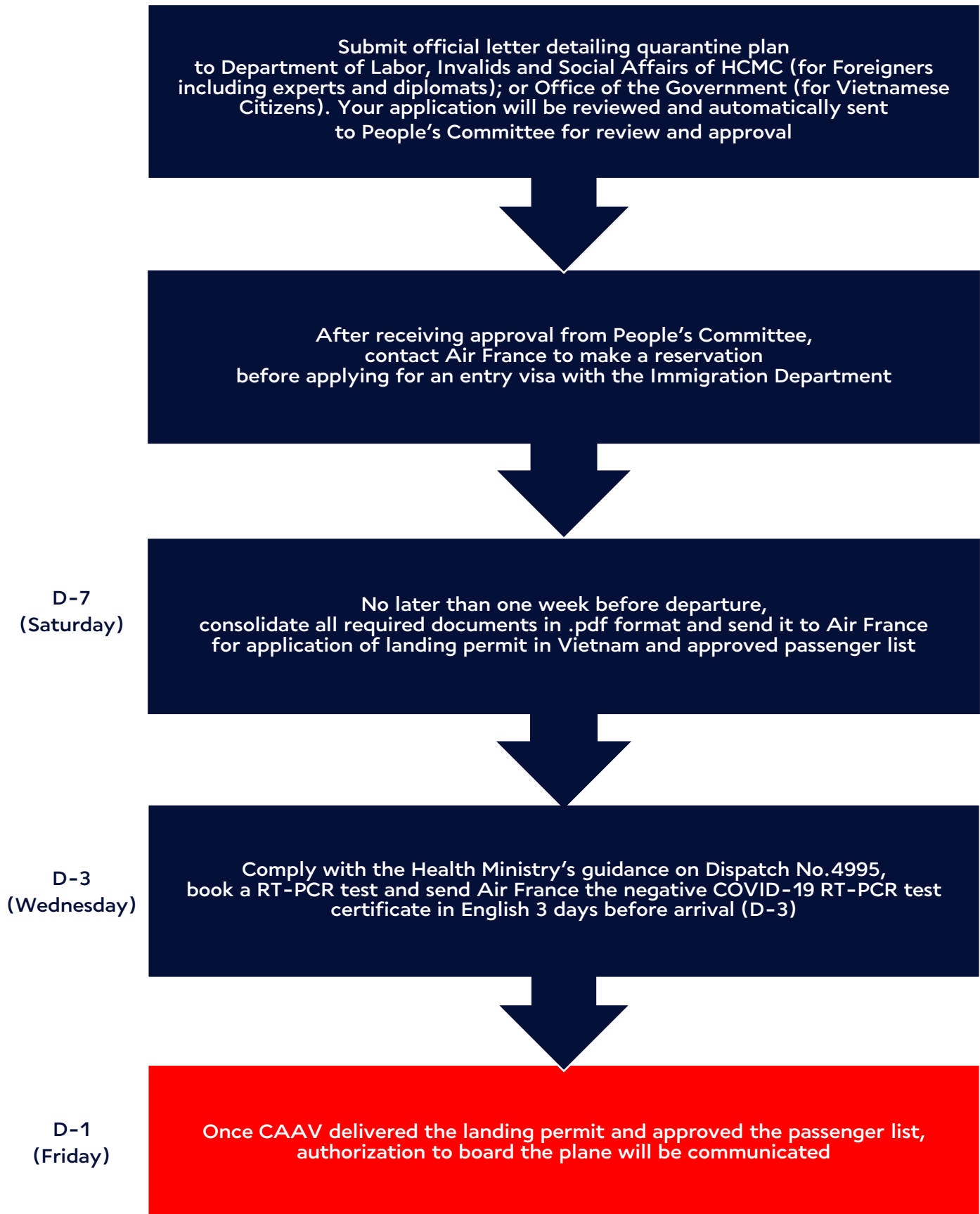

DOCUMENT CHECKLIST – FOR FOREIGNERS (EXPERTS & DIPLOMATS)

All documents* are required before ticket issuance (*hard copies required when traveling)

- Copy of Passport**
(Validity of 6 months prior to departure required)
- Approval from People’s Committee of Ho Chi Minh City or province**
(Ủy Ban Nhân Dân)
- Approval from Immigration Department**
(Cục Quản Lý Xuất Nhập Cảnh)
- Confirmation of Hotel Booking for quarantine and Transportation Booking**
- Negative SARS-CoV-2 (COVID-19) RT-PCR test certificate in English using genetic material detection (RNA) testing technique of virus (Real Time RT-PCR) from at a laboratory approved by the Government. Sample/test date must be within 3-5 days before entry into Vietnam (i.e. perform detection test **as from Wednesday D-3**)**

- International-coverage insurance or commitment from invited company or organization on all expenses if passengers are tested COVID-19 positive**
