RESOLUTION

Promulgating the Temporary Regulation "Safely and flexibly adaptation, effectively controlling the COVID-19 pandemic"

THE GOVERNMENT

Pursuant to the Law on Government Organization dated on 19 June 2015; The Law amending and supplementing a number of articles of the Law on Government Organization and the Law on Organization of Local Government dated on 22 November 2019;

Pursuant to Law on Prevention and Control of Infectious Diseases dated on 21th November 2007

Pursuant to Resolution No. 30/2021/QH15 dated on 28 July 2021 by the National Assembly on the first session, the XV National Assembly;

Based on the proposal by the Minister of Health and unanimous opinion of the members of the Government,

DECIDES:

- **Article 1.** To promulgate together with this Resolution the temporary regulation "Safely and flexibly adaptation, and effectively controlling the COVID-19 pandemic".
 - **Article 2.** This Resolution comes into effect from the date of signing.
- **Article 3.** Ministers, heads of ministerial-level agencies, heads of government-attached agencies, chairmen of People's Committees of provinces and centrally run cities, heads of provincial steering committees for COVID-19 prevention and control and relevant agencies, organizations and individuals are responsible for the implementation of this Resolution.

TEMPORARY REGULATIONS

"Safe and flexible adaptation, effectively controlling the COVID-19 pandemic" (Attached to Resolution No. 128/NQ-CP dated on October 11, 2021 by the Government)

The World Health Organization, scientists and countries believe that the COVID-19 pandemic cannot be completely controlled before 2023; There may be new strains of the virus that are more dangerous, making the pandemic complicated and unpredictable. However, the coverage of vaccines and drugs for treatment help reduce the number of severe cases, deaths and decrease of infection rate. Therefore, many countries have changed their pandemic response strategies from trying to completely extinguish the disease to living safely with the disease.

In Vietnam, some experiences have been initially drawn from the actual practice of pandemic prevention and control; the response capacity of the health system has been gradually improved; Vaccination coverage, especially for high-risk groups and large cities is rapidly increasing helping us to be more proactive in pandemic prevention and control.

From the actual situation, analysis of scientists, experts, opinions of localities and the National Steering Committee for COVID-19 prevention and control, the Government has determined the goals of the pandemic prevention and control is still a key task in order to maximally protect the health and life of the People, restore and develop socio-economic, ensure security, social order and safety; shift the strategy of pandemic prevention and control to "safe and flexible adaptation, and effectively controlling the COVID-19 pandemic".

The Government promulgates the temporary Regulation "Safe and flexible adaptation, effectively controlling the COVID-19 pandemic" (hereinafter referred to as the Regulation).

I. OBJECTIVES

To have maximum protection of people's health and lives; to minimize infected cases, severe disease transfer, and death due to COVID-19; socio-economic restoration and development, ensuring security, social order and safety; realize the dual goal of bringing the whole country to a new normal state as soon as possible, striving in 2021.

While the rate of vaccine coverage is being accelerated but has not yet reached universal coverage and drugs to treat COVID-19 are being developed and put into use, but there is no specific drug; the objectives are to ensure the uniform implementation of regulations and instructions of ministries and branches, while promoting the initiative and creativity of the locality in controlling the pandemic situation, creating conditions for the restoration of production and business., develop socio-economic, bringing people's daily life gradually back to the new normal; do not let the local situation and each locality with different rule in the promulgation and implementation of solutions above the necessary level, leaving to negative impact on production, business, and social life.

II. OPINION

1. Ensuring dual goals but putting people's health and life first, first and foremost; solutions for pandemic prevention and control must be based on science, suitable to the country's reality and conditions; ensure that people are protected

against pandemics at the best, able to access to medical services at the earliest and fastest, right from the grassroots; but does not cause congestion for circulation and production.

- 2. Strengthening the leadership and direction of the Party; mobilize the whole political system; uphold the responsibilities of Party committees and authorities at all levels, the responsibility of leaders in pandemic prevention and control, realizing dual goals; ensure uniform leadership and direction throughout the country, and at the same time promote the initiative and creativity of governments at all levels, especially at the grassroots level.
- 3. In pandemic prevention and control, pandemic prevention must be fundamental and long-term; health care force is the core force along with the army, police, ... but must mobilize the participation of all forces and classes in society. The role of people and businesses should be promoted as the center and subject in pandemic prevention and control, in safe production, business and living.
- 4. Solutions of safe and flexible adaptation solutions and effective control of the COVID-19 pandemic must be implemented decisively, promptly and drastically; ensure harmony between medical professional solutions with administrative, economic and social solutions. Medical solutions must be synchronized between isolation with testing, treatment and vaccines, under the motto "isolation and testing are the key, vaccines and drugs are prerequisites".

III. CLASSIFICATION OF ASSESSMENT AND DETERMINATION OF PANDEMIC LEVEL

1. Classification of pandemic level

Level 1: Low risk (new normal) – green.

Level 2: Medium risk - yellow.

Level 3: High risk - orange.

Level 4: Very high risk - red.

2. Range of pandemic level assessment

Assessment is from the commune level. Encourage assessment is encouraged from the smallest possible scale (below the commune level) to ensure flexibility and efficiency.

- 3. Criteria for pandemic level assessment
- a) Rate of new cases in the community/population/time.
- b) Vaccine coverage (note the high-risk age group, rate of first dose injection, rate of full dose).
- c) Capability to accept and treat at gland (note clearly specifying the capacity of receiving, existing use and treatment and additional plans).
 - 4. Determination of pandemic level
 - a) The Ministry of Health shall guide the criteria and methods of assessment and determination of the pandemic level;
 - b) Based on the guidance of the Ministry of Health on assessment and determination of pandemic level and pandemic situation in the area, the People's Committee of the province or city directly under the central government decides to change the pandemic level. In case of upgrading the pandemic level, it is

required to notify at least 48 hours in advance to people, organizations and businesses, and prepare before it is applied.

IV. MEASURES TO APPLY FOR PANDEMIC LEVEL

Medical measures including medical isolation, testing, collection, treatment and vaccination are implemented according to the guidance of the Ministry of Health at all levels.

V. TERMS OF APPLICATION

1. This provision is applied uniformly throughout the country. Based on the instructions of the Ministry of Health and other ministries and branches, the People's Committees of the provinces and cities shall decide on appropriate administrative measures, including specific regulations and instructions on capacity, no of participants in production, business, service, culture, arts, events, etc., and can flexibly apply specific additional measures that are not contrary to regulations of the central government, do not cause

congestion of goods circulation, production and business, travel and daily life of the people. In case the Central Government's regulations and guidelines are not suitable and feasible, they shall promptly report to the agency promulgating regulations and guidelines. The agency promulgating regulations and guidelines must immediately direct to remove obstacles and study amendments to regulations and guidelines.

- 2. Chairpersons of provincial-level People's Committees shall decide to apply medical isolation for the area (block down the outbreak) at the most quickly and as narrowly as possible and implement activities to ensure social security and access to medical services, so that people can secure to comply with regulations on pandemic prevention and control.
- 3. It's required temporarily to not apply the provisions of Clause 1, Article 1 of the Government's Resolution no 86/NQ-CP dated on August 6, 2021 and the Directives No. 15/CT-TTg on March 27, 2020 by the Prime Minister Government, Directive No. 16/CT-TTg dated on March 31, 2020 by the Prime Minister, Directive No. 19/CT-TTg on April 24, 2020 of the Prime Minister, Decision No. 2686/QD-BCDQG May 31, 2021 by the National Steering Committee for COVID-19 prevention and control. In case it is necessary to apply pandemic prevention and control measures on a province-wide scale, higher than those specified in this Regulation, the chairperson of the provincial-level People's Committee shall report to the Ministry of Health and the Prime Minister.

VI. IMPLEMENTATION

- 1. Ministries, ministerial-level agencies, agencies attached to the Government
- a) It's required to issue new instructions or updating and amending the issued guidelines and to strengthen the direction of implementation to ensure the motto of safe and flexible adaptation, and effective control of the COVID-19 pandemic under its management of sectors and fields for localities, agencies, organizations and individuals to apply;
- b) Promptly remove difficulties, handle unexpected and arising problems related to pandemic prevention and control for localities;
- c) It's required to carry out the procurement to serve the COVID-19 pandemic prevention and control in accordance with regulations; transparency; ensure saving and prevent and fight against negativity, waste and corruption;
- d) It's required to timely reward; strictly handle violations against the law in the COVID-19 pandemic prevention and control.
 - 2. The Ministry of Health
- a) It's required to issue guidance on classification criteria, pandemic level assessment and medical professional measures; In which, the factor that has been vaccinated against COVID-19 or has recovered from COVID-19 is noted in regulations related to travel, medical isolation, production and business organization, and participation in crowded activities;
- b) It's required to continue to implement solutions to improve the capacity of the health system, especially preventive medicine and grassroots health; deploy safely, scientifically and effectively the vaccination campaign against COVID-19 in nationwide; develop a roadmap for children's vaccination and booster vaccination;
- c) It's required to update and publicize pandemic areas and pandemic levels in all localities in the country on the website of the Ministry of Health as a basis for localities to apply measures to manage people coming from pandemic areas and other localities;
- d) It's required to assume the prime responsibility for, and coordinate with the Ministry of National Defense and the Ministry of Public Security in preparing mobile forces to promptly strengthen localities in case the pandemic exceeds the local pandemic control

- 3. The Ministry of National Defense
- a) It's required to continue to strengthen control to ensure security of borders, trails and openings;
- b) It's required to continue to mobilize military forces, especially the medical forces, chemical troops, border guards, militia and self-defense forces to closely coordinate with the health sector and localities in pandemic prevention and control; participate in the production and supply of equipment and supplies and in the relief of people in quarantined areas.
 - 4. The Ministry of Public Security
- a) It's required to assume the prime responsibility for organizing functional forces to ensure security, order, social safety and cyber security, especially at grassroots and in medical isolation areas; strengthen the prevention and fight against all kinds of crimes, especially against functional forces participating in the COVID-19 pandemic prevention and control; strictly handle those who take advantage of the pandemic prevention and control policy;
- b) It's required to continue to closely coordinate with the Ministry of Health, provinces and cities in organizing the implementation and arrangement of forces to participate in the COVID-19 pandemic prevention and control, to ensure social security;
- c) It's required to connect the population database with data on vaccination, testing and management of people infected with COVID-19 who have recovered from the disease to uniformly deploy the application of QR codes on citizen identification cards (or an appropriate form for those who do not have a new citizen identification card) to serve the management of people's movement and the COVID-19 pandemic prevention and control.
 - 5. The Ministry of Information and Communications
- a) It's required to assume the prime responsibility for promoting the application of information technology in pandemic prevention and control; technical standards for connection, to ensure safety and security of information and citizens' personal data;
- b) It's required to assume the prime responsibility for, and coordinate with the Central Propaganda Department in directing press agencies and grassroots information systems to proactively and promptly provide information and disseminate knowledge on COVID-19 prevention and control;
- c) It's required to direct information and communication agencies to strengthen propaganda to create consensus and social trust; promote self-discipline and positivity of people in pandemic prevention and control; to guide safe, flexible adaptation measures and effective control of the COVID-19 pandemic to raise people's awareness in the new situation.
 - 6. The Ministry of Labor Invalids and Social Affairs
- a) To preside the implementation of regimes and policies to support those affected by COVID-19;
- b) To preside and coordinate with relevant departments in proposing solutions to ensure social security and support children, employees and employers; proposing solutions to restore the labor market.

7. The Ministry of Foreign Affairs

To continue to promote health diplomacy, especially vaccine diplomacy, monitor and synthesize countries' experiences on safe adaptation to COVID-19 to inform promptly to domestic agencies. To propose options for "vaccine passport" and "mutual recognition of

vaccine passport".

- 8. The Ministry of Industry and Trade
- a) To direct of securing goods, raw materials and energy to meet the requirements of production and business recovery and socio-economic development;
- b) To preside and coordinate with agencies in proposing competent authorities to remove difficulties and obstacles for important industrial projects; Maximum support factories to maintain and restore production to keep orders and supply chain.
 - 9. The Ministry of Agriculture and Rural Development
- a) To adjust actively agricultural production plan to avoid supply shortage in the coming time. To seek domestic raw materials to produce animal and poultry feed, reducing dependence on imported sources;
- b) To seek out actively sources of consumption of agricultural products in harvest period, especially in key livestock and agricultural production areas, and closely coordinate with the Ministry of Transport, the Ministry of Industry and Trade, and localities to ensure favorable and smooth conditions for agricultural transportation and consumption

10. The Ministry of Transport

- a) To guide construction activities of traffic projects and works to ensure safe, flexible adaptation and effective control of COVID-19 pandemic;
- b) To review instructions and plans for traffic activities, inter-provincial transportation, goods circulation, ensuring continuity of production supply chains, etc. to adapt safely, flexibly, and effectively control of COVID-19.

11. The Ministry of Construction

- a) To guide on construction activities of projects and construction works to ensure safe, flexible adaptation and effective control of COVID-19 pandemic;
- b) To update requirements to ensure COVID-19 and infectious diseases prevention and control in construction plannings, especially housing plans for workers in industrial zones and clusters...
 - 12. The Ministry of Natural Resources and Environment
- a) To review guidance on handling and transportation of waste generated in Covid 19 prevention and control
- b) To direct the strength of capacity for safe waste treatment in Covid 19 prevention and control.

13. The Ministry of Finance

To propose mechanisms and solutions to ensure resources for pandemic prevention and control; to complete institutions, mechanisms and policies to promote socialization and public-private partnership for pandemic prevention and control.

14. Ministry of Planning and Investment

- a) To preside for making and completing strategies and plans for socio-economic restoration and development;
- b) To preside and coordinate with relevant agencies in proposing solutions to remove difficulties and support enterprises; preferential policies to attract foreign investors.
 - 15. The Ministry of Education and Training
 - a) To cooperate with the Ministry of Health in reviewing guidelines for COVID-19

prevention and control in education and training activities;

- b) To continue to implement solutions to ensure a safe and effective implementation of 2021-2022 school year in COVID-19 situation in each locality;
- c) To cooperate with the Ministry of Health to organize vaccination for school-age students.

16. The Ministry of Culture, Sports and Tourism

To review guidelines for safe, flexible adaptation and effective control for Covid 19 in cultural, sports and tourism activities.

17. The Ministry of Science and Technology

To mobilize scientists and experts to research and propose solutions for Covid 19 prevent and control; to strengthen research and implementation of research programs and scientific and technological tasks on vaccination, biological products, equipment,... for Covid 19 prevention and control.

18. The Ministry of Justice

- a) To preside and coordinate with relevant agencies in proposing solutions to remove institutional bottlenecks, amending legal provisions that are no longer appropriate, causing obstacles and hindering production and business activities in disease conditions;
- b) To preside and coordinate with relevant agencies in proposing the application of regulations on sanctioning administrative violations due to objective circumstances and the impact of COVID-19 pandemic.

19. The Ministry of Interior

- a) To review operating instructions of establishments, places, religious activities, beliefs and worship to ensure Covid 19 prevention and control of COVID-19
- b) To advise the Government and the Prime Minister to launch emulation movements in COVID-19 prevention and control, socio-economic recovery and development. To coordinate with the Ministry of Health, ministries, branches and localities to propose timely commendation of collectives and individuals with outstanding achievements in COVID-19 pandemic prevention and control and economic recovery.

20. The Committee for Ethnic Minorities

- a) To coordinate with the Ministry of Health, the Ministry of Information and Communications and localities to strengthen the mobilization ethnic minority people areas to participate in Covid 19 prevention and control;
- b) To coordinate with the Ministry of Labor, War Invalids and Social Affairs to propose supporting policies to ensure social security for ethnic minorities affected by COVID-19.

21. The Government Inspector

To direct the organization of periodic and irregular inspection in Covid 19 prevention and control in order to combat negativity, corruption and waste

22. State Bank of Vietnam

To propose credit solutions to support businesses, organizations and individuals to restore production, business, and socio-economic development. To promote strongly non-cash, contactless payment methods.

23. The Committee for Management of State Capital at Enterprises

To propose solutions to support state-owned enterprises to restore production, safely and flexibly adapt, and effectively control COVID-19

24. Vietnam Academy of Science and Technology, Vietnam Academy of Social Sciences

To strengthen scientific research on pandemics, disease prevention and control; the impact of pandemic on all aspects of social life; recommend solutions to the Government, the Prime Minister and the National Steering Committee for COVID-19 prevention and control scientific to improve the effectiveness of COVID-19 prevention and control, restoring production and business, social economic development.

25. Vietnam News Agency, Vietnam Television Station, Voice of Vietnam

To strengthen communication to create response and participation of the society in implementing the redirection of strategies for COVID-19 prevention and control according to this Resolution. Reflecting and analyzing the results of pandemic prevention and control, socio-economic recovery, promoting the good traditional values of the nation in pandemic prevention and control. Timely cheering and praising typical examples of collectives and individuals, anti-pandemic models, effectively realizing dual goals.

Strengthening information on the situation and forecast of pandemics situation in the world; scientific and technical advances, new solutions in pandemic prevention and control.

- 26. The Government proposes the Vietnam Fatherland Front and organizations:
- a) To strengthen coordination with authorities at all levels in mobilizing people to raise their awareness and voluntarily comply with pandemic prevention and control measures; continue to mobilize organizations and enterprises to both prevent and combat the pandemic, overcome the consequences caused by the pandemic, while maintaining and developing production and business activities,... promote the spirit of innovation, creation of all classes of people in pandemic prevention and control, realize dual goals;
- b) To coordinate actively with the authorities at all levels to effectively solve pressing social problems at the grassroots, participate in propaganda, advocacy and supervision of the implementation in Covid prevention and control measures in the locality.
 - 27. People's Committees of provinces and centrally run cities
- a) Develop and implement a safe, flexible adaptation plan to effectively control the COVID-19 pandemic with a specific and feasible roadmap, ensuring effective control of the COVID-19 pandemic. Organize the effective implementation of pandemic prevention and control measures in accordance with pandemic developments in each locality;
- b) Follow the instructions of the Ministry of Health for testing, isolation and medical monitoring of people coming from pandemic areas and other localities; people entering the country (including children who have not been vaccinated or given insufficient doses of vaccine); people who have completed concentrated isolation are able to move smoothly to their places of residence/stay and work to serve the restoration and development of production;
- c) Update information and data serving the determination of the pandemic level according to the direction of the Ministry of Health. Based on the pandemic situation in the locality, the pandemic level and measures shall be announced accordingly;
- d) Direct the implementation of measures to prevent and control the COVID-19 pandemic and restore economic development with the spirit of initiative, creativity, sticking to reality, not being subjective when the pandemic passes; ensure the motto "four in place"; carry out the procurement to serve the Covid 19 prevention and control in accordance

with regulations, ensuring publicity, transparency, closeness, prevention and control of negativity, waste and corruption;

- dd) Strengthening the work of urging and inspection to the grassroots level, preparing necessary conditions to be ready to respond quickly when the pandemic situation changes.
- 28. The Government assigns the Ministry of Health to assume the prime responsibility for, and coordinate with the Government Office in monitoring the implementation of this Resolution and promptly reporting to the Prime Minister if any problems arise.
