The Vietnamese Landscape

ENVIRONMENT

- Rapid economic growth led to many challenges: air and water pollution, waste management limitations, and biodiversity loss.
- Increasing awareness and demand for sustainable solutions and responsible business practices.
- Government initiatives such as promoting renewable energy, urban design and stricter environmental regulations.

SOCIAL

- Demographic shifts: Vietnam's aging population raises concerns about issues like pension sustainability and healthcare access for the elderly.
- Labor market concerns: There are ongoing challenges regarding labor rights, workplace safety, and fair treatment of marginalized groups.
- Social development: Growing emphasis is placed on improving education, healthcare, social welfare systems for all citizens.

GOVERNANCE

- Anti-corruption efforts: significant steps in recent years to combat corruption, but further progress is needed.
- Corporate governance: fostering transparency, accountability, and ethical leadership is crucial especially to attract FDI and access to green funding.
- Regulatory environment: efforts are required to streamline and modernize regulations to promote sustainable practices.
